# A Parent's Guide to Special Educational Needs & Disabilities at

## All about Special Educational Needs

Approximately one in five children will have special educational needs (SEN) at some time during their school career.

This means they may have difficulty with:

- Reading, writing, mathematics
- Understanding information and others and expressing themselves
- Organising themselves
- Sensory perception or physical mobility
- Managing their behaviour

The length of time required to address the Special Educational Needs will vary from child to child.

These difficulties cause barriers to the child's learning. The school will assess your child to identify their strengths, needs and the extra help they require.

### At St James & St John we follow the **Bucks Graduated Approach to SEN model:**

1. A child may be requiring Early Support – whereby they need a short-term intervention, or Continuing Support.
2. Continuing Support may require long term interventions, which may remain the same, or may change in relation to the child's progress.
3. Advice from outside specialists may be sought at any time, e.g. specialist teacher, speech and language therapist, health

professional, which may lead to extended support.

4. **Education and Health Care Plan:** when it is agreed that Universal Provision is insufficient for the child's needs an application is made for an EHCP Needs Assessment with the supporting evidence from external agencies.

### What is offered to your child?

The school offers the following according to your child's special educational needs:

- Quality first teaching
- Universal Provision
- Curriculum to match needs
- Enhanced access to ICT
- In-class support from teaching assistants
- Catch-up literacy/numeracy programmes
- One-to-one or small group work with a learning support assistant
- Differentiated homework
- Test concessions
- Extra help and advice sought from external agencies

Particular targets may be drawn up in consultation with the Special Educational Needs Coordinator (SENCO). These targets are usually termly, and reviewed accordingly. They are recorded in the format of an Individual Educational Plan (IEP). This document will be discussed with the parents/carers, usually on a termly basis.

### Outcomes for pupils

The extra help the school offers will enable the child to:

- Reach their full potential
- Achieve their personal best
- Make progress
- Feel valued and included
- Enjoy School
